**Rules (Scottish Section)**

1. Teachers and Highland competitors should be conversant with, and conform to the rulings of the S.O.B.H.D.
2. Classes will be sub-divided or combined according to number of entries.
3. Entries must be made on the appropriate official entry form and be returned to the address given below, with the appropriate fees by the closing date. Cheques should be made payable to the Slough Arts Festival. Fees cannot be refunded in the event of cancellation.
4. Age. Age of a Competitor is taken as on day of competition. Competitors may not enter classes out of their age group.  
 No competitor may dance more than once in the same class except in the broadswords where a maximum of 1 person may make up another team.
5. Change of status: Any competitor's change of status must be notified immediately to the organiser. An additional £2 will be charged if left until the day of the competition.
6. Adjudicator's Decision. In all sections the adjudicator's decision is final. Communication with the adjudicator by competitors or other interested parties is forbidden and breach of this rule renders a competitor liable to disqualification. The section committee has the right to resolve any question or dispute which may arise concerning the section and this decision is final.
7. Should any unforeseen circumstances arise the committee reserve the right to modify or cancel any event at their discretion.
8. All trophies remain the property of the Slough Art's Festival. Trophy winners will be held responsible for loss/damage while in their possession. No trophies may be taken out of the country. Trophies must be returned in good condition for presentation at the current Festival.
9. Gold, Silver and Bronze medals will be awarded at the discretion of the adjudicator.  
 Certificates will be awarded where appropriate.
10. Responsibility: Slough Arts Festival cannot accept responsibility for any injury to competitors or loss of personal property or equipment, wherever such loss may occur.
11. Photographs: Only authorised photographers will be permitted to take photographs. Under no circumstances will flash photography be allowed during performances or adjudications. Video, still or mobile photography is not permitted under British Federation of Music Festivals regulations and Copyright law.
12. Music copyright: The festival is affiliated to the British Federation of Music Festivals and participates in its Group Licence to cover payment of fees for the use of recorded music at its events. Teachers using tape from commercial recordings are reminded to seek advice in order to comply with the Copy right Act.
